ARTICLES OF INCORPORATION
OF
L & D COMPANY

TO ALL TO WHOM THESE PRESENTS MAY COME:

We, whose names are hereunto subscribed, all of whom are citizens of the United States of America and bona fide residents of the State of Idaho, and each of us being of full, legal age, do under and pursuant to the General Corporation Laws of the State of Idaho, associate ourselves together for the purpose of becoming a body corporate, and do now declare these are the Articles of Incorporation of L & D COMPANY, a corporation.

ARTICLE I

The name of this corporation shall be:

L & D COMPANY.

ARTICLE II

The purposes for which this corporation is formed are:

- a. To do each and all and every kind of business that will aid in the operation of said corporation, including that of borrowing money and the execution of all necessary papers incident thereto.
- b. To do each and everything necessary or useful or advisable for the enhancement of anyone or more of the said operations or which shall appear to be for the benefit of said corporation in connection therewith.
- c. To comply with Sub Chapter S, United States Code, and any small business act or investment act as provided by the Statutes of the United States of America.

ARTICLE III

The principal place of business of said corporation shall be Kasiska Building, Pocatello, Bannock County, Idaho.
