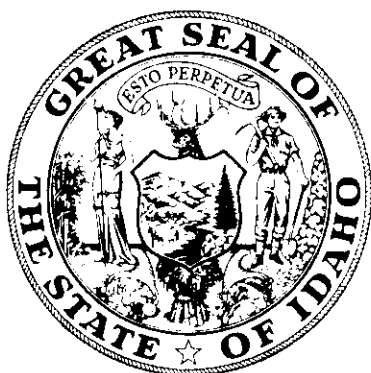

ARTICLES OF INCORPORATION
OF
FLIGHT FOR ALL SEASONS, INC.

The undersigned, acting as the incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation.

FIRST: The name of the corporation is Flight For All Seasons, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purposes for which the corporation is organized are the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 5,000 at the par value of \$10.00 per share.

FIFTH: Provisions for the regulation of the internal affairs of the corporation are provided in the by-laws and as said by-laws may be from time to time amended.

SIXTH: The address of the initial registered office of the corporation is 360 B Street, P.O. Box 309, Idaho Falls, Bonneville County, Idaho, 83402, and the name of its initial registered agent at such address is Roger B Wright.

SEVENTH: The number of directors constituting the initial board of directors of the corporation is six and the directors are: Roger and Marsha Ball, Harold and Verla Ball, Wayne and Norma Virgin, at the said address of 360 B Street, Idaho Falls, Bonneville County, Idaho who shall serve as such directors until the first annual meeting of the shareholders or until their successors and/or any additional directors are elected and qualify.
