

ARTICLES OF AMENDMENT

ARTICLES OF INCORPORATION
OF
UNIQUE FIBERGLASS LTD.

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is Unique Fiberglass Ltd.

SECOND: The following amendments of the Articles of Incorporation were adopted by the stockholders of the corporation on March 13, 1984, in the manner prescribed by the Idaho Business Corporation Act:

I.

That the provisions of Article V of the Articles of Incorporation of Unqiue Fiberglass Ltd. be deleted in their entirety.

II.

That the new Article V of the Articles of Incorporation of Unique Fiberglass Ltd. be as follows:

The corporation shall have the authority to issue 25 million shares of no-par value common stock. All of said stock shall be nonassessable, voting, common stock of one single class having equal rights, powers, and preferences.

THIRD: The number of shares of the corporation outstanding at the time of such adoption of the Amendment to the Articles of Incorporation was 70 shares; and the number of shares entitled to vote thereon was 70 shares.

FOURTH: The number of shares voted for such amendment was 70 shares; and the number of shares voted against such amendment was 0 shares.

FIFTH: The manner in which the exchange of \$100 par value common stock for the issue of new no-par value stock provided for in the amendment shall be at a ratio of 1:48,571.428 which will result in an exchange of shares of stock as follows:

SIXTH: The 30 shares of \$100 par value common stock authorized but unissued are cancelled.

SEVENTH: There is no change in the amount of the stated capital of the corporation as a result of this amendment to the Articles of Incorporation.

These Articles of Amendment to the Articles of Incorporation of Unique Fiberglass Ltd. are executed by the undersigned, constituting all of the stockholders of Unique Fiberglass Ltd., and done pursuant to a duly enacted Resolution of the stockholders of Unique Fiberglass Ltd. dated March 13, 1984, without a formal stockholders' meeting, but pursuant to Idaho Code Section 30-1-145.
