ARTICLES OF INCORPORATION OF THE CRAIG MOUNTAIN CATTLE CO., LTD..

We, J.C.Nordby, of Genesee, J.L.Goodnight, of Genesee, S.D.White, of Lewiston, U.G.Dickson, of Genesee, J.K.Bell, of Genesee, Idaho, do by these presents, pursuant to and in conformity to the laws of the State of Idaho, in reference to Corporation, associate ourselves together and form a corporation for the purpose of conducting a general cattle and live stock business.

First. The name of said corporation shall be the Craig Mountain Cattle Co., Limited.

Second. The purpose for which this corporation is formed is to buy and sell livestock of all kinds, to lease, buy and sell real estate, and to deal in personal and real property as may be necessary to the general benefit of a live stock business.

Third. The place where the <sup>principal</sup> ~~general~~ business of this company shall be conducted shall be in the city of Genesee, Idaho, County of Latah.

Fourth. The term for which this corporation shall exist shall be fifty years from and after the date of this incorporation.

Fifth. The number of directors of this incorporation shall be five and the respective names and residences of the persons who shall be the directors for the first year are as follows, viz.,

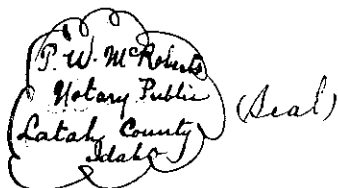
