Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is LARRYDALE FARMS, INC.

SECOND: The following amendments of the Articles of Incorporation were adopted by the shareholders of the corporation on Gove 23, 1989, in the manner prescribed by the Idaho Business Corporation Act:

RESOLVED, that the corporation's name is changed to PLINE FARMS, INC.

THIRD: The number of shares of the corporation outstanding at the time of such adoption was 1,050; and the number of shares entitled to vote thereon was 1,050.

FOURTH: All stock comprises one (1) class of common stock and all 1,050 shares are entitled to vote on the amendment.

FIFTH: The number of shares voted for such amendment was 1,050; and the number of shares voted against such amendment was 0.
