

ARTICLES OF INCORPORATION OF
EAST GREENACRES GROWERS ASSOCIATION

KNOW YE ALL MEN BY THESE PRESENTS, That we, the undersigned all of whom are bona fide residents of the State of Idaho, have voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we do hereby certify as follows:

I.

That the name of the Corporation shall be

EAST GREENACRES GROWERS ASSOCIATION.

II.

That the purpose for which this corporation is formed shall be

To establish an institution or agency through which a community of farmers and fruit growers may co-operate together intending, harvesting, preparing, advertising, and marketing their products, and in purchasing, manufacturing, and providing their supplies; and to enable the corporation to carry out these objects it shall have power:

First: To act as agent for any farmer or fruit grower in any lawful business connected with such calling, and to charge and collect a compensation for such services;

Second: To build, buy, lease, or acquire, and to own, hold, manage, or operate fruit packing houses, cold storage plants and warehouses, box mills process mills, and by-product factories, produce markets stores and supply houses; and to operate and carry on every other kind of business pertaining to farming, fruit-growing or gardening, or to farm, orchard, or garden products, or to the implements, materials, or supplies used or consumed therein, or by those engaged in such industries

Third: To purchase, lease, or acquire, and to own, hold or operate farms, orchards, and other real estate; and to mortgage lease or sell the same as the Corporation or its Directors shall see fit; and

Fourth: To borrow money, and to issue bonds and notes and make mortgages, contracts and indorsements, and to do any and all things necessary or incident to the convenient management and operation of the business of said Corporation, as herein expressed, in all of its branches

III.

That the place for the principal business to be transacted is at Grand Junction in Kootenai County, Idaho, and that the post office address of said place wherein said business shall be transacted is Post Falls, in Kootenai County, Idaho.

IV.

That the term for which said corporation is to exist is fifty (50) years of and from the date of incorporation.

V.

That the number of Directors shall be not less than three (3) nor more than seven (7) which number may be changed from time to time at the annual meeting of the Stock Holders but until such change shall be made there shall be three (3) Directors, who shall act until their successors are elected and qualified and the names and residence of those appointed are as follows, to-wit:

That the amount of capital stock of said corporation is twenty five thousand dollars (\$25,000.00) and the number of shares into which the same is divided is five hundred dollars (\$500,00) of the par value of fifty dollars (\$50.00) each.
