from the date hereof, with its registered office in this State located

at Gooding in the County of Gooding

and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 30, Idaho Code.

ARTICLES OF INCORPORATION

That the FIRST SOUTHERN BAPTIST CHURCH OF GOODING, IDAHO, a voluntary association of Gooding, Gooding County, Idaho, through its presiding officer, caused notices to be printed, published and posted according to law, notifying the members of the association that at a certain time and place in Gooding, Gooding County, Idaho, a meeting would be held at which an election would be held for the purpose of determing whether or not said association should be incorporated under the laws of the State of Idaho and who should act as trustees, and at an election held at said time and place, a resolution was adopted authorizing the incorporation of said association, at which election all members present, capable thereof, voted and by said vote declared unaminously that said organization should be incorporated and that the hereinafter named persons be trustees thereof to hold office until the annual election held by said corporation or until their successors were duly elected and qualified, and pursuant to said resolution and election and the actions taken at said meeting, it was determined that the name of this corporation should be the FIRST SOUTHERN BAPTIST CHURCH OF GOODING, IDAHO, INC., and the trustees elected should act as incorporators.

The objects of said corporation are to establish a church in the town of Gooding and in connection therewith, suitable and customary organizations for the purpose of worship and religious training according to the rules and manual of said church. The FIRST SOUTHERN BAPTIST CHURCH OF GOODING, IDAHO, under the supervision of CLAYLAN COURSEY, JOHN GUINN and OVA EVERETT, trustees of said organization to take charge of the church building, estate, property and affairs of the temporalities thereof.

That the principal place of business of this corporation shall be in Gooding, County of Gooding, State of Idaho.

That the term for which it is to exist shall be fifty years.

The number of its trustees shall be three, CLAYLAN COURSEY, JOHN GUINN and OVA EVERETT, who are citizens of the United States of America and over the age of twenty-one years, and who shall hold office until the next annual election and until their successors are duly elected and qualified.

That this corporation shall have no capital stock and is not organized for the purpose of profit.
