ARTICLES OF INCORPORATION

STATE

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned being natural persons of full age, citizens of the United States, have this day voluntarily associated ourselves together for the purpose of forming a corporation under and pursuant to Title 30, Chapter 1, Sections 1 through 152 of the Idaho Code, and we do hereby certify as follows:

ARTICLE ONE  
(Name)

The name of this corporation shall be SHANNON'S GOLD DEVELOPMENT EXPLORATION CO., INC.

ARTICLE TWO  
(Purposes)

The purpose for which said corporation is formed shall include, but not be limited to, as follows:

1. The general nature of its business shall be to search for, prospect, develop, and explore for ores and minerals with all the corporate capacity and corporate authority contained in Section 30-1-4 of the Idaho Code, in the United States of America, or in foreign countries.

2. The private property of Officers, Directors, Stockholders, shall not be subject to payment of Corporate debts to any extent whatever.

3. The number of Directors of the Corporation shall be not less than three (3) nor more than seven (7), that the number, qualifications, terms of office, manner of election, time and place of meetings, and powers and duties of the Directors and Officers shall be such as are prescribed by the by-laws of the Corporation, that the names of the first Directors who shall hold

office and manage the affairs of the Corporation for a period of one (1) year after its incorporation are as follows:

#### ARTICLE THREE (Duration)

This Corporation shall have perpetual existence.

#### ARTICLE FOUR (Registered Office)

The location and Post Office address of the registered office in this State and the principal place of business shall be 642 Mylarol Avenue, Moscow, Idaho, 83843, and it is registered by Mr. Robert S. Williams.

#### ARTICLE FIVE (Stock)

This Corporation is authorized to issue one class of shares of stock, the total number of which is Six Million (6,000,000) with a par value of One (1¢) Cent which stock may be issued by the Corporation from time to time as determined by the Board of Directors hereof.

Each share of common stock shall have one (1) vote and cumulative voting rights for Directors. Shares of stock of this Corporation shall not be subject to assessment.
