ARTICLES OF INCORPORATION

of

YBARRONDO & ASSOCIATES - SCIENTECH, INC.

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, Ybarrondo & Associates - Scientech, Inc., has adopted the following Articles of Amendment to its Articles of Incorporation:

The name of the corporation is Ybarrondo & Associates - Scientech, Inc.

II

The following amendments to the Articles of Incorporation were adopted by the shareholders and directors of the corporation on April 21, 1988, in the manner prescribed by the Idaho Business Corporation Act:

RESOLVED, that Article VI of the Articles of Incorporation of the corporation be amended to read as follows:

VI

The aggregate number of shares which this corporation shall have authority to issue shall be 5,000 shares of nonassessable voting common stock having a par value of one cent per share.

RESOLVED FURTHER, that a new article be added to the Articles of Incorporation of the corporation to read as follows:

VIII

Should the capital stock of the corporation be increased at any time, the shareholders at the time of such increase shall be

entitled to a pro rata share of such increase, in proportion to their holdings at the time of the increase, upon the payment of the par value thereof.

III

The number of shares of the corporation outstanding at the time of such adoption was 4,000, and the number of shares entitled to vote thereon was 4,000.

IV

The number of shares voted for such amendment was 4,000, and the number of shares voted against such amendment was 0.

V

Such amendment does not effect a change in the stated capital of the corporation.
