MINUTES OF SPECIAL JOINT MEETING OF STOCKHOLDERS AND BOARD OF DIRECTORS OF ABBOTT AUTO SUPPLY, INC.

A Special Meeting of the stockholders and Board of Directors of Abbott Auto Supply, Inc., on the <u>AGEN</u> day of October, 1979, at <u>2:00 P.M</u> o'clock P. m., and pursuant to written waiver signed by all of the stockholders and members of the Board of Directors.

It appeared from signed, written consent of shareholders to dissolve, that a voluntary dissolution of the above-named Corporation should be made pursuant to the provisions of the Idaho Business Corporation Act and the following resolution was, upon motion, duly made, seconded and unanimously adopted.

WHEREAS all of the shareholders of the above-named Corporation have heretofore consented in writing that said Corporation dissolve, and the Corporation desires to adopt a procedure for such dissolution.

NOW THEREFORE be it resolved that the above-named Corporation be dissolved; that the Corporation proceed to collect all its assets, pay, satisfy and discharge its liabilities and obligations or adequately provide for the payment of all such obligations; cause notice of such plan for dissolution to be mailed to each of its known, actual or potential creditors not less than 30 days prior to the filing of Articles of Dissolution; convey and dispose of such of its properties as are not to be distributed in kind to its shareholders and such as are not necessary to pay the creditors, and after the running of said 30 day period, cause the officers and directors of the Corporation to execute and file with the Secretary of State duplicate Articles of Dissolution pursuant to Section 30-1-92 of the Idaho Business Corporation Act.

BE IT FURTHER RESOLVED that within 30 days after this meeting the Corporation file Form 966 with the District Director of the Internal Revenue and assist the shareholders to have their gain taxed as provided in Paragraph 333 of the Internal Revenue Code of 1954, in preparing forms 964 and filing the same within 30 days of this meeting, and that the officers and directors of the Corporation be, and they are hereby empowered and authorized to carry out the provisions of this resolution and to adopt any further resolutions that may be found necessary in liquidating and dissolving the Corporation.

There being no further business, the meeting adjourned.
