ARTICLES OF INCORPORATION

OF

GOOD SENTZ PRODUCTS, INC.

The undersigned, acting as incorporators of a corporation, under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such Corporation:

FIRST: NAME The name of this corporation shall be GOOD SENTZ PRODUCTS, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purposes for which this corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act. The Corporation shall have the power to do anything not prohibited by law necessary or requisite for the furthering of the purposes of this corporation.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 5,000 shares of no-par stock.
