

BLOCK 2: To change the registered agent or office, strike the incorrect information and write in the correct information. Note: The office of the registered agent must be at a street address in Idaho; not a Post Office Box or Personal Mali Box.

BLOCK 3: Only a new registered agent must sign in Block 2.

BLOCK 4: Enter names and business addresses of president, secretary, and directors (for corporations only) or managers/members (for LLC's only). Note: Putting "same as last yeer" or "same as above" will not be accepted. Changes here will not affect the address in Block 1.

BLOCK 5: May not be altered through the use of this form.

BLOCK 5: The annual report must be signed by a person authorized to represent the conporation/LLC. Print or type the name and title of the signer below the signature.

If the (corporation/Limited Liability Company) is no longer doing business in Idaho, you may like the appropriate form and fee. Forms are available on our website at www.idaos.state.id.us. However, if no timely annual report is filled, administrative action will be taken, at no cost to the (corporation/Limited Liability Company), to terminate the legal existence.
