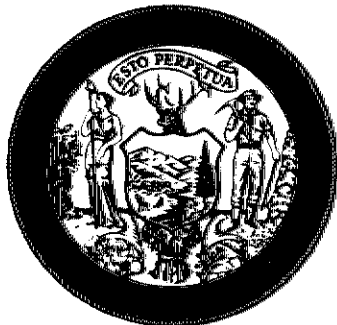

ARTICLES OF INCORPORATION

The undersigned, WILLIAM C. PASTOOR, being a person of full legal age, does hereby form a domestic corporation under and pursuant to the laws of the State of Idaho, and does hereby certify:

FIRST: The name of this Corporation shall be WESTOWNS' DISPOSAL, INC.

SECOND: This Corporation is formed for the purpose of transacting any or all lawful business for which corporations may be incorporated under the laws of the State of Idaho including, but not limited to, the operation of the business of garbage and solid waste pick up and disposal for the communities of Marsing, Homedale and Wilder, Idaho.

THIRD: The period of existence and duration of the life of this Corporation shall be PERPETUAL.

FOURTH: The location and post office address of the initial registered office of the Corporation in the State of Idaho shall be 1025 12th Avenue South, Nampa, Idaho, 83651, which place shall be the principal office for the transaction of business for the Corporation. The initial registered agent of the Corporation at such address shall be Reese E. Verner, Attorney at Law.

FIFTH: This Corporation is authorized to issue one class of shares of capital stock to be designated as common stock. The total number of the shares of said common

stock which this Corporation shall be authorized to issue is 1,000. The stock shall have no par value.

SIXTH: The name and post office address of WILLIAM C. PASTOOR, the incorporator of this Corporation, is as follows: Post Office Box 754, Homedale, Idaho, 83628.

SEVENTH: The capital stock of this Corporation shall be non-assessable and the private property of the shareholders of this Corporation and shall not be liable for the debts, obligations and liabilities of this Corporation.

EIGHTH: The number of the directors of this Corporation shall be one (1) or such additional numbers as provided in the By-Laws of the Corporation. The number of directors constituting the initial board of directors shall be one (1). The name and address of the person who is to serve as director until the first annual meeting of shareholders or until a successor is elected and qualifies is WILLIAM C. PASTOOR, whose address is as above stated.

NINTH: The By-Laws of this Corporation shall be formulated, repealed, and/or amended upon the affirmative vote of a majority of the directors of this Corporation, at a meeting of the directors duly called and held for that purpose.


