DAVID TESTER, being over the age of 18 years and a citizen of the United States of America, hereby makes and files these Articles of Incorporation with the purposes of establishing a corporation for the transaction of the business and the promotion and conduct of the objects and purposes herein stated under the laws of the State of Idaho and hereby certifies as follows:

ARTICLE I

The name of this corporation (hereinafter referred to as "the corporation") is PetZ, Inc.

ARTICLE II

The corporation shall have perpetual existence.
