CERTIFICATE OF INCORPORATION

I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of

IDAHO STATE BOWLING ASSOCIATION, INC.

was filed in the office of the Secretary of State on the **15th** day of **January** A. D. One Thousand Nine Hundred **Sixty** and is duly recorded on Film No. **110** of Record of Domestic Corporations, of the State of Idaho, and that the said articles contain the statement of facts required by Section 30-103 and Sections 30-1001 to 30-1005, inclusive, Idaho Code.

I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name hereinbefore stated, for **perpetual existence** from the date hereof, with its registered office in this State located at **Boise,** in the County of **Ada,** and as such are subject to the rights, privileges and limitations granted to Non-Profit Cooperative Associations as provided in Chapter 10, Title 30, Idaho Code.

ARTICLES OF INCORPORATION
of
IDAHO STATE BOWLING ASSOCIATION, INC.

KNOW ALL MEN BY THESE PRESENTS That we, the undersigned, being natural persons of full age and citizens of the United States and of the State of Idaho, in order to form a corporation for the purposes hereinafter stated pursuant to the Business Corporation Act of Idaho, do hereby certify as follows:

ARTICLE I.

The name of the corporation is IDAHO STATE BOWLING ASSOCIATION, INC.

ARTICLE II

The purpose for which said corporation is formed is:

(a) To provide means of rendering assistance and cooperation to City Associations and to help provide a uniformity of program and closer cooperation between all City Associations within the State. To provide means of uniting all teams and bowlers in the State at an annual State Tournament, the results of which shall determine the five-men, individual and all-events championships of the State. It shall provide, adopt and enforce among its participants a uniform standard of rules and regulations which shall govern the annual Idaho State Bowling Association Tournament and provide and adopt a standard of regulations and conditions for the conduct of State Tournaments and to foster the spirit of good fellowship and highest ideals of American tenpins and a better feeling among American Bowling Congress members that this body will remain the same as similar State Organizations.

ARTICLE III

The corporation is to have perpetual existence.

ARTICLE IV

The location and post office address of the registered office of the corporation is 215 Boise Avenue, Boise, Idaho.

ARTICLE V

There are no authorized shares in the corporation, the corporation being a non-profit organization, and the rights and interests of all members shall be equal.

ARTICLE VI

The number of directors of the corporation is at least four.

ARTICLE VIII

The officers of the corporation shall consist of such officers as may be designated upon further membership.

ARTICLE IX

Members of this corporation by a majority vote shall have the power to repeal or amend by-laws thereof and to adopt a new code of by-laws if in their discretion that becomes proper.


