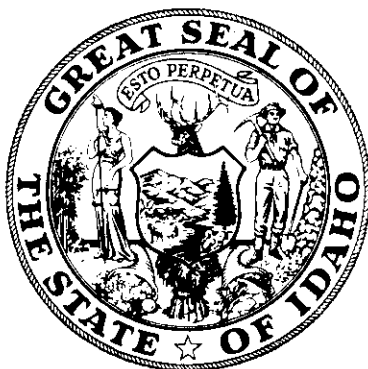

ARTICLES OF INCORPORATION

The undersigned natural person of full age, acting as incorporator of a private corporation under the laws of the State of Idaho, hereby adopts Articles of Incorporation as follows.

ARTICLE ONE

The name of the corporation is STARSYSTEM, INC.

ARTICLE TWO
