Articles of Incorporation

In order to form a Non-Profit Corporation under the provisions of Title 30, Chapter 3, Idaho Code, the undersigned submits the following articles of incorporation to the Secretary of State.

ARTICLE 1: Name

The name of the corporation shall be: Gate City High School, Inc.

ARTICLE 2: Purposes and Powers

This Corporation is organized exclusively for the charitable, educational, and innovative purposes in order to do all things reasonable and proper in the operation of a nonprofit charter school within the state of Idaho. This corporation is organized exclusively for educational purposes within the meaning of IRC Section 501(c) (3) of the Internal Revenue Code and shall not carry on any activities prohibited under said code or corresponding sections of any future federal internal revenue laws.

Under the statutes of the state of Idaho, this corporation has been formed and designated as a nonprofit entity and not created for pecuniary profit. In accordance with Idaho Law, no part of the income or assets of the corporation are distributable to or for the benefit of its Incorporators, Directors, Officers, or private persons. The Corporation shall have all powers allowed by law, including, without limitation, those powers described in Section 30-2-24 of the Idaho Code. Furthermore, the corporation shall not engage in any activities or execute powers not in direct furtherance of this corporation's stated and inferred purposes.

In accordance with federal regulation, the corporation shall not discriminate against applicants, students, faculty, and staff based on race, color, or nation or ethnic origin.

ARTICLE 3: Registered Office and Agent

The address of the registered office of the Corporation is 800 W. Riverton Rd, Blackfoot, Idaho 83221, and the name of its initial registered agent is Joel F. Weaver.

ARTICLE 4: Directors

The number of individuals constituting the board of directors shall be fixed by the Bylaws, but shall not be less than three (3) and no more than five (5). The number of directors constituting the initial Board of Directors shall be three (3), of which the names and address are as follows:

ARTICLE 8: Dissolution and Distribution

Upon the dissolution of the Corporation the assets of the Corporation shall be distributed to creditors pursuant to Sections 30-3-114 and 30-3-115 of the Idaho Code. Upon dissolution of this corporation and adequate reimbursement of debts, the remaining assets shall be distributed to the Pocatello School District No. 25.

ARTICLE 9: Non-stock Corporation

No pecuniary profits or dividends shall be paid to the incorporators and/or directors, nor shall any certificates of stock be issued.

ARTICLE 10: Bylaws

The Bylaws shall set for the necessary provisions for the regulation for the internal affairs of the corporation.

ARTICLE 11: Amendment to Articles

These Articles may be amended only upon the unanimous consent of the Directors.
