## ARTICLES OF INCORPORATION OF 83 APR 18 AM 8 52 MUSTANG MINING COMPANY, INC.

- 1. NAME: The name of the corporation is MUSTANG MINING COMPANY, INC.
- 2. PERIOD OF DURATION: The period of duration of the corporation is perpetual.
- 3. <u>PURPOSE</u>: The purpose for which this corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the laws of the State of Idaho, as those laws may be amended from time to time, including without limitation, the exploration, acquisition, development, operation, and mining of properties along with all activities incident or related thereto.
- 4. <u>INITIAL BUSINESS</u>: The corporation's initial business: To acquire, explore, develop, operate, and mine real properties and to participate in all activities incident or related thereto.
- 5. <u>AUTHORIZED CAPITAL</u>: The corporation shall have the authority to issue 200,000 shares of common stock, no par value.
- 6. <u>INITIAL STOCK ISSUANCE</u>: The initial issuance of the corporation's common stock shall be five thousand (5,000) shares each to the individuals whose names and addresses are set forth in paragraph 8 of these Articles.
