AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for perpetual existence from the date hereof, with its registered office in this State located at Post Falls, in the County of Kootenai, and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 30, Idaho Code.

ARTICLE 1.

Name

Sec. 1. The name of this corporation shall be the Falls Full Gospel tabernacle inc. of Post Falls, Idaho. The principal address of the corporation shall be located at 12th and Spokane in Post Falls, Idaho, or such other places as may be designated by the Directors of this corporation.

ARTICLE 2

Sec. 2. Perpetua; duration

ARTICLE 3

The purposes of this corporation shall be of a religious, charitable, evangelistic, character, having for its purposes the winning of souls and the establishment of the people's hearts in the sound Christian Truth: Salvation and water and Holy Spirit Baptism. The rogram to be conducted shall be entirely undenominational and interested of all denominations shall receive the finest type of Bible training and ministerial instruction, regardless of their ability to pay for the promotion of companionship, spiritual following among the people of the community, to receive and disburse voluntary contributions for the interested eogle, to establish, regulate and control; and to furnish ritual, forms, ceremonies, cards, supplies and certificates; to provide necessary symbols and signs of identificates; to stand relief and sid to people; to have and to hold religious and social gatherings and meetings; to improve the intellectual, and spiritual welfare of the interested coale through tible studies, lectures, ceresonies, and mutual visitation, and through any other means which will create to operate to improve the intellectual, moral and spiritual welfare of the interested people.

To license and ordain and send out Pastors, Evengelism and Missionaries.

ARTICLE 4

Stock and Membership

Sec. 1. There shall be no capital stock and the members of the corporation shall be those teo le who are members of the congregation of the Falls Full Gospel Tabernacle Inc.

There shall be no membership dues except in such amounts as each member may, in his opinion, be the correct and just amount for mim to give and carry on the work of this corporation, such contributions to be based upon the tithe system. The property of the corporation will not be distributed unless the corporation be dissolved by a vote of its members or in accordance with law.

ARITCLE 5

Meetings

- Sec. 1. The annual meeting of the corporation shall be held on the first Monday in November of each and every year or at such other times as may be designed.
- Sec. 2. Special meetings of the members of this corporation may be held at the principal place of business of the corporation upon the call of the President, Vice-president.
- Sec. 3. The regular meeting of the Board of Directors shall be held in the principal office of the corporation.

 Special meetings of the Board of Directors may be held upon the call of the President or and two Directors by the giving of not less than 3 days notice to each Director. A majority of the Eirectors shall constitute a quorum.

ARTICLE 6

Officers

Sec. 1. The officers of this corporation shall be a President, Vice-president, Secretary and Treasurer, and two

trustees who shall be elected for the duration of life and shall hold office until death or resigned. The Pastor of said Falls Full Gospel Tabernacle shall be president and shall hold office until he has resigned, or death. The office of Secretary and Treasurer may be combined within the discretion of the Board of Directors.

Sec. 2. The President shall preside at all Directors and officers meetings, shall have general supervision of the affairs of the corporation and over other officers; and shall perform all such other duties as are incident to his office.

In case of the absence or disability of the President, his duties shall be performed by the Vice-president.

Sec. 3. The Secretary shall give notice of all Director's and member's meetings and shall attend and keep the minutes of the same; shall have charge of all corporate books, records and papers; shall be custodian of the corporate seal and shall attest signature and impress with the corporate seal all written contracts of the corporation.

Sec. 4. The Treasurer shall sign all checks of the corporation, shall keep all regular books or accounts, shall submit them with all of the vouchers, receipts and other records.

Sec. 5. The officers of the incorporation will appoint a special Secretary to handle the offering moneys for the pastor and the Sunday school moneys to be received every Sunday morning.

Sec. 6. Notice of the time and place of the annual and special meetings shall be mailed by the Secretary to concerned 10 days before the date thereof.

Sec. 7. The President, or in his absence the Vice-president, shall preside at all meetings, whether annual or special.

Sec. 8. At each meeting the members shall be entitled to cast one vote as hereintofore provided, which vote may be cast either by him in person or by proxy. All proxies shall be in writing and shall be filed with the Secretary and by him entered of record in the minutes of the meeting.

Sec. 9. A quorum for the transaction of business at any meeting shall consist of 2/3 of the members and in the event a meeting is called and there is not a quorum present, those present may adjourn the meeting, designating the time in the future at which it shall be held.

Sec. 10. Non-profit -- no capital stock and all real and personal stock shall belong to the incorporation.

ARTICLE 7

Sec. 1. Vacancies in the Board of Directors by reason of death, resignation, or other causes, shall be filled by the remaining Directors choosing from among the members of the corporation a director to fill the unexpired term.

Sec. 2. The business and property of the corporation shall be managed by the Board of Directors and they shall exercise all the powers that may be exercised or performed by the corporation under the statutes, certificates of incorporation and by-laws. Each Director must be a member of the corporation and shall receive no compensation for his services as such Director. The treasurer shall give bond in such sum as the Directors may require.

APTICLE 8

Punds

Sec. 1. The funds of the Corporation shall be deposited in such bank or trust company as the Directors shall designate and shall be withdrawn only by checks or order of the President or Vice-president, or by the Treasurer.

ARTICLE 9

Sec. 1. The Falls Full Gospel Tabernacle Inc. being an independent church chall be able to acquire properties for the church operations and not to be sold but to be perpatually indopendent and owned by the Wolls Will Gos al Tabernacle Inc.
