ARTICLES OF INCORPORATION
OF

KNOW ALL MEN BY THESE PRESENTS, that we the undersigned being of full legal age and citizens of the United States, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and hereby adopt Articles of Incorporation as follows:

I

The name of the corporation shall be FRONTIER ENTERPRISES, INC.

II

The nature of the business of the corporation, its objectives and purposes shall be to have and exercise all the powers now and hereafter conferred by the laws of the State of Idaho upon corporations organized pursuant to the laws under which this corporation is organized and any and all acts amendatory thereof and supplemental thereto.

III

The term of existence of this corporation shall be perpetual.

IV
