General. However, the liability of any of the Limited Partners for the losses of the Partnership shall in no event exceed in the aggregate the amount of his/her contributions to the capital of the Partnership, plus an amount equal to any of his/her undistributed profits which have been realized. The General Partners, after giving effect to the losses chargeable against the Limited Partners as herein provided, shall bear all other Partnership losses. It is agreed and it shall be the policy of the Partnership that no Limited Partner shall be entitled to receive interest on his/her capital contribution to the Partnership.

- 4. A new paragraph 14 shall be added to the Certificate of Limited Partnership of Lloyd F. Randall Farms which provides as follows:
  - 14. The registered agent for service of process on Lloyd F. Randall Farms Limited Partnership shall be Scott Young Randall whose address is 3616 East 880 North, Menan, Idaho 83434.
