ARTICLE I

NAME

The name of this corporation is: Emipals, Inc.

ARTICLE II

DURATION

The duration of this corporation shall be perpetual.

ARTICLE III

PURPOSE

The puropses for which this corporation is authorized to perform includes all lawful pursuits including manufacturing & distribution of children's furniture.

ARTICLE IV

POWERS OF THE CORPORATION

This corporation shall not commence business until consideration of a value of at least \$1,000.00 has been received for the issuance of shares of Common Stock.

Common or interested Directors may be counted in determining the presence of a quorum at a meeting of the Board of Directors or committee thereof which authorizes, approves or ratifies such contract or transaction.
