The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is **Barber Valley Development, Inc.**

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The purpose, objectives and business of the Company shall be to invest in, acquire, own, improve, operative, develop, sell, exchange, lease or otherwise conduct any business with respect to real property or interest therein for profit and to enter into and perform contracts of any kind and engage in all activities necessary or incidental thereto in the interest of the Shareholders. The Company exists only for the purpose specified in this Article III and may not conduct any other business without the unanimous consent of the Shareholders.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is 1,000 Shares of \$1.00 par value for an aggregate authorized capital of \$1,000.00.

ARTICLE V
