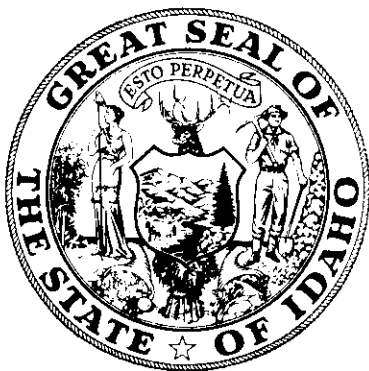

ARTICLES OF INCORPORATION  
OF  
GEORGE MILEY INSURANCE, INC.

The undersigned, acting as incorporator under the provisions of the Idaho Business Corporation Act, adopts the following Articles of Incorporation:

1. NAME. The name of the corporation shall be:

GEORGE MILEY INSURANCE, INC.

2. DURATION. The period of its duration is perpetual.

3. PURPOSES. The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

4. STOCK. The corporation shall have the authority to issue FIVE HUNDRED THOUSAND (500,000) shares of capital stock, all of one (1) class. The par value of each share of stock shall be TEN & 00/100 DOLLARS (\$10.00).

5. ADDRESS. The address of the initial registered office of the corporation is:
