

Certificate of Incorporation

Name. First. The name of this corporation is CENTRAL UTILITY SERVICES, INC.

Address. Second. The address of the principal office of this corporation in the State of Tennessee is 416 East Brooks Road, Memphis, Shelby County, Tennessee.

Business. Third. The general nature of the business to be transacted by this co-poration is to engage in the application of wood preservative materials to poles, pilings, crossies, lumber and other like items, and in the application of industrial herbicides. In general, to carry on any other lawful business whatsoever in connection with the foregoing or which is calculated directly, or ing directly, to promote the interest of the corporation or enhance the value of its properties.
