ARTICLES OF INCORPORATION

OF

L & T, INC.

SEGRETAND OF STATE

The undersigned, in order to form a corporation pursuant the Idaho Business Corporation Act, certify as follows:

ARTICLE I

The name of the corporation is L & T, Inc. (hereafter "Corporation").

ARTICLE II

The purposes for which this Corporation is organized are as follows:

- 1. To engage in the business of Trucking, and
- 2. To engage in any other lawful activity of business for which corporations may be incorporated under the Idaho Business Corporation Act.
