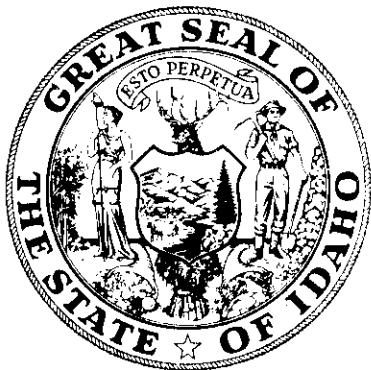

ARTICLES OF AMENDMENT

MARSCHALL, PRESTON & ASSOCIATES, INC.

Pursuant to § 30-1-61 of the Idaho Business Corporations Act of the State of Idaho, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

ONE: The name of the corporation is MARSCHALL, PRESTON & ASSOCIATES, INC.

TWO: The following amendment to the Articles of Incorporation was adopted by the Board of Directors of the corporation on October 3rd, 1983, in the manner prescribed by the laws of the State of Idaho, and the Articles of Incorporation of the corporation:

RESOLVED, that the Articles of Incorporation of this corporation be amended by changing Article 1 thereof so that, as amended, said Article shall be and read in its entirety as follows:

ARTICLE 1

The name of the corporation is VERN MARSCHALL & ASSOCIATES, INC.

THREE: On October 3rd, 1983, pursuant to resolution of the Board of Directors of the corporation, such amendment was submitted to the stockholders of the corporation for their written consent, and by such consent, 100% of the shares as required by statute were voted in favor of the amendment.
