

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION

OF

HENRY-GRIFFITTS, INC.

Articles of Amendment to the Articles of Incorporation of HENRY-GRIFFITTS, INC. are herein executed by said Corporation pursuant to the provisions of Section 30-1-59, et seq., of the Idaho Business Corporation Act, as follows:

- 1. The name of the Corporation is HENRY-GRIFFITTS, INC.
- 2. The amendments to the Articles of Incorporation of said Corporation are as follows:
 - A. Paragraph 1, Article V shall be amended to read as follows:

"ARTICLE V

1. The aggregate number of shares this Corporation shall have authority to issue is five million (5,000,000) shares, consisting of two (2) classes as follows:

VOTING COMMON:

Two Million Five hundred Thousand (2,500,000) shares with a par value of Ten Cents (\$.10) per share.

NONVOTING COMMON: Two Million Five

Hundred Thousand (2,500,000) shares with a par value of Ten Cents (\$.10) per

share."

C. A new Article IX shall be added to read as follows:

"ARTICLE IX

Shareholders of this Corporation shall not have cumulative voting rights."

The stock split approved by the directors pursuant to which this Amendment is executed provides for the exchange, reclassification, or cancellation of issued shares in that each shareholder of the Corporation's currently outstanding voting and nonvoting common stock would be given the opportunity to exchange one (1) of such shares, having a par value of Ten Cents (\$.10) per share for twenty-five (25) shares of voting or nonvoting common stock, respectively, having a par value of Ten Cents (\$.10) per share. All of the currently outstanding shares which are exchanged in the stock split will be canceled.
- 7. The amendment effects an increase in the amount of stated capital of the Corporation from two hundred thousand (200,000) shares with a par value of Ten Cents (\$.10) per share to five million (5,000,000) shares with a par value of Ten Cents (\$.10) per share.
