As provided for under Title 30, Chapter 3, of the Idaho Code, otherwise known as the Idaho Nonprofit Corporation Act, the undersigned individuals submit the following amendments to those original Articles of Incorporation filed on August 21, 1986 and on file with the Idaho Secretary of State's Offices as nonprofit corporation # 81995.

The name of the corporation is the **BOGUS BASIN HILLCLIMB ASSOCIATION, INC.**

All provisions of the original Articles of Incorporation and the amendments to the Articles of Incorporation, Dated september 1, 1989, not specifically mentioned or modified herein shall remain as written in full force and effect.

Amendment to Article 3 - The provisions of Article 3, as amended of September 1, 1989, are stricken in their entirety and amended to read as follows:

ARTICLE 3


The purpose of this corporation shall be the promotion, organization, and administration of the Bogus Basin Hillclimb event, an automotive event which takes place at the Bogus Basin Ski Area near Boise, Idaho and also the Freezeout Hillclimb event, an automotive event which takes place near Emmett, Idaho. and to include any such automotive events for promotion, organization, and administration as deemed appropriate by the board of directors, and presented to the membership at any regularly scheduled meeting, and approved by majority vote by the membership present.

All amendments as offered herein were adopted by consent by all members entitled to vote with respect thereto.
