This document is to effect notice, and to certify affirmation of such action to be taken as is set out below, by the unanimity of stockholders in VIKING PLUMBING AND HEATING, INC., and Idaho corporation, as regards amendment to said corporations Articles of Incorporation.

It is by authority of the following excerpt from the Idaho Code, that the undersigned stockholders of said corporation do hereby affirm that they are in unanimous agreement to change the legal name of the corporation to more fully and accurately reflect operations.

Section 30-146, Item # 5 states that:

Any amendment which might be adopted at a meeting of shareholders as provided in this section, may be adopted without such meeting being held if written consent to the amendment has been given by all shareholders entitled to vote thereon as provided.



It is noted that the change in name as proposed is the only action authorized by indorsement to this document, except those directly incidental to said change, or required thereof.


