ARTICLE I

The purpose and objects for which esaid corporation are formed are as follows:

- A. To conduct and carry on a general service, repair, manufacture and sales of business throughout the United States of America and foreign countries which this corporation may qualify to engage in such business in.
- B. To acquire and take over the whole or any part of the business, property, assets, contracts or liabilities, of any firm, person or corporation engaged in the same or similar business to acquire any property, real or personal, necessary or reasonably convenient for the carrying on of its business; to erect, hold, own, acquire, purchase and dispose of offices or buildings and generally to do and performall acts proper or necessary for the purpose of said business.
