
CERTIFICATE OF INCORPORATION OF

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is Western Concrete Construction, Inc.

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The corporation is organized for the purpose of conducting and transacting any or all lawful business in the State of Idaho, including but not limited to concrete contracting; concrete construction; dealing in concrete products and services associated with such products; general construction contracting; and any and all lawful activities associated with the construction industry.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is 100, which shares shall have no par value.

ARTICLE V

Provisions for the regulation of the internal affairs of the corporation are as shall be set forth in the Bylaws of the corporation as from time to time adopted or amended.




