

This is to certify that the undersigned have this day united themselves and formed a corporation under the corporate name of the Idaho Agricultural Park Association,

The company is formed for the purpose of owning ground, erecting buildings and improvements thereon, making a driving track and holding and conducting Agricultural Exhibitions, Fairs, horse and cattle Shows, and trials of speed of horses,

The amount of the capital stock of the association shall be fifteen thousand dollars,

The time of its existence shall be ninety nine years,

The stock shall consist of one hundred and fifty shares of one hundred dollars each,

There shall be seven Trustees and John Hoaley, E. Smith, Jr., Pinkham, J. D. Agnew, A. J. Harston, J. H. Boston and E. C. Sterling shall be the trustees to manage the concerns of the association for the first three months,

The principal place of business of the association shall be located in Boise city, county of Ada, Territory of Idaho.
