**ONE:** The name of this corporation is Ravenscraig Corporation.

**TWO:** The purpose of this corporation is to engage in any lawful act or activity for which a corporation may be organized.

**FOUR:** This corporation is authorized to issue only one class of shares of stock which shall be designated common stock. The total number of shares it is authorized to issue is 1,000,000 shares, with no par value.

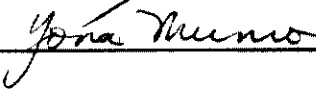
**EIGHT:** The duration of this corporation will be perpetual.
