ARTICLES OF AMENDMENT TO CHARTER OF GLOBAL POWER COMPANY

Global Power Company, a corporation organized and existing under the laws of the State of Tennessee, does hereby amend its Charter as follows:

- (a) The name of the corporation is Global Power Company.
- (b) The amendment so adopted is to change the name of the corporation to A & H Company, Inc.
- (c) The amendment was adopted by unanimous vote of the directors and shareholders at meetings held on October 28, 1983.
- (d) The amendment shall be effective when filed by the Secretary of State.
