ARTICLES OF INCORPORATION

OF

RARE EARTH AND MINERALS, INC.

ARTICLE I NAME OF CORPORATION

The name of the corporation is Rare Earth and Minerals. Inc.

ARTICLE II DURATION

The corporation shall exist perpetually or until dissolved according to law.

ARTICLE III PURPOSES

The purpose of the corporation is to engage in any lawful acts or lawful activities under the Idaho Corporation Act including, but not limited to: the prospecting for, exploration for, development, production, refining, processing, storage, marketing, and use of metals, oil and gas, gemstones and other minerals; the buying, owning, selling, leasing, conveying, subletting and assigning of real and personal property of all types; and the development and improvement of real property.

ARTICLE IV CAPITALIZATION

The aggregate number of shares which the corporation shall have authority to issue is One Million (1.000,000.) shares of common stock having a par value of \$0.01 per share. All voting rights of the corporation shall be exercised by the holders of the common stock, with each share of common stock being entitled to one vote. All shares of common stock shall have equal rights in the event of dissolution or final liquidation.

ARTICLE V CUMULATIVE VOTING

Holders of common voting stock shall have Cumulative voting rights in the election of the Board of Directors.

ARTICLE VI NO PREEMPTIVE RIGHTS

No holder of shares of the capital stock of any class of the corporation shall have any preemptive or preferential rights of subscription to any shares of any class of stock of the corporation.

ARTICLE VII COMMENCEMENT OF BUSINESS

The corporation will not commence business until consideration of the value of at least One Thousand Dollars (\$1,000,) has been received for the issuance of shares.

ARTICLE VIII REGISTERED OFFICE AND AGENT

The address of the initial registered office of the corporation is 976 Valencia Street, Boise Idaho **3**3706, and the initial registered agent at such address is David S. Perkins.

ARTICLE IX DIRECTORS

The number of directors which shall constitute the Board of Directors of the corporation may vary from three to nine directors as prescribed by the bylaws.
