The undersigned, acting as incorporator of a Nonprofit Corporation, under the Idaho Nonprofit Corporation Act, adopts the following Articles of Incorporation for such Corporation.

#### FIRST

The name of the Corporation is BROOKSIDE HOMEOWNER'S ASSOCIATION, INC.

#### SECOND

The period of the duration is perpetual.

## THIRD

The purpose or purposes for which the Corporation is organized are: The transaction of any and all lawful business for which Nonprofit Corporations may be incorporated under the Idaho Nonprofit Corporation Act.

The Corporation is specifically created to transact any and all lawful business purposes related to management and protection of conditions and covenants in a homeowners association.

#### FOURTH

The Corporation shall have voting members defined as the titled owner(s) of a lot in the Brookside Addition, Divisions 1 through 6, of the City of Idaho Falls, Idaho, and as may be further defined, identified and described in the Corporation's Bylaws.

# FIFTH

Upon dissolution, all assets of the Corporation shall be distributed in accordance with Idaho Code § 30-3-109 and other applicable provisions of law.

## SIXTH

The Corporation shall have power to authorize assessments to be levied upon all members in equal or different amounts or proportions and may exempt some members from assessments. The amount and method of collection of assessments shall be fixed by the board of directors, from time to time, and shall be payable at such times or intervals, and upon such notice and by such methods as the directors may prescribe.
