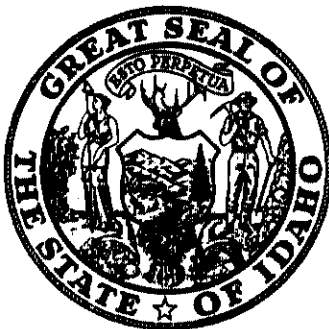

The undersigned, acting as incorporator under the provisions of the Idaho Business Corporation Act, adopts the following Articles of Incorporation:

1. NAME. The name of the corporation is: FUN FOR RENT, INC.

2. DURATION. The period of its duration is perpetual.


