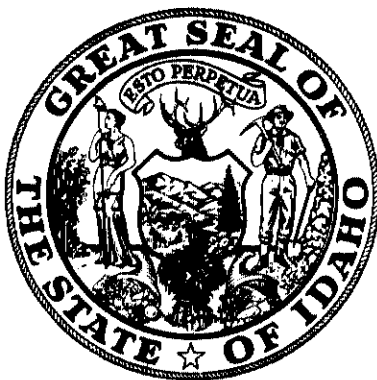
CERTIFICATE OF INCORPORATION

**ARTICLES OF INCORPORATION**

**NAME**

1. The name of the corporation is NORTHWEST BEE SUPPLIES, Inc.

**DURATION**

2. The period of it's duration is perpetual.

**PURPOSE**

3. The purpose or purposes for which this corporation is formed are as follows:
  - (a) The purpose of Northwest Bee Supplies Inc., shall be to engage in the business of manufacturing, selling, marketing, and using bee boards and any or all related activities of any kind or description; and
  - (b) Except as otherwise prohibited by Idaho law, the corporation, in furtherance of it's corporate purposes set forth above, shall have all of the powers necessary and proper for the effectuation of any and all legitimate enterprises of the corporation, subject to any limitations provided by the laws of the State of Idaho.

**AUTHORIZED SHARES**

4. It shall have authority to issue One Hundred Thousand (100,000) shares, all of one class, at no par value.

### VOTING

5. Each shareholder shall have equal voting power, and a super majority vote shall be required, (70%) as to all matters, including, but not limited to; issuing new stock, acquisition or sale of corporate shares, merger, altering the nature of the corporation, amending the Articles or Bylaws, or transferring assets of the corporation in any matter not the ordinary course of business.




