ARTICLES OF AMENDMENT TO THE TO THE ARTICLE OF INCORPORATION OF ASPEN FINANCIAL GROUP, INC.



Pursuant to the provision of Section 31-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:
