ARTICLES OF INCORPORATION \

OF

ONE CALL TRANSPORTATION, INC

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned being over the age of twenty-one years and citizens of the United States of America, have this day voluntarily associated ourselves together for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho, and we do hereby certify;

ARTICLE I_

NAME

The name of this corporation shall be ONE CALL TRANSPORTATION, INC

ARTICLE II

Purposes

The purpose for which this corporation is formed are,

(a) To broker freight, to own, operate and maintain and
to construct, acquire by purchase, lease or otherwise, trucks, trucklines,
facilities, and equipment for the purpose of transporting passengers
freight, mail, express, baggage, goods, wares, merchandise, and other
property of every kind and nature.

- (B) To conduct, engage in and carry on the business of transportation of property of every class and discription and of persons, and by any means of transportation now or hereafter in use.
- (C) To own, operate, maintain, hold and use, purchase, contract, establish, lease, or otherwise acquire, mortgage or sell, or otherwise dispose of or deal with terminal properties and depots, freight and passenger station uses, storage facilities, machine and repair shops, freight, stock and repair yards, facilities of communication by telegraph, telephone, radio, television or otherwise, elevators, wharves, docks, cars, rolling stock, motors, buses, trucks, automobiles and all structures, tools, machinery, appliances, and any and all other property, real, personal, or mixed, and wheresoever situated, and whether or not similar to any property above described which may be necessary or useful in connection with the business of this corporation.

- (d) To buy and sell securities, mortgages, debentures, and other evidences of debt, subject to the provisions of law. To purchase, or otherwise acquire, hold and re-issue the shares of its capital stock. To acquire by purchase, subscription, or otherwise, and to hold and dispose of stock, bonds, or any other obligations of any corporation formed for, engaged in, or pursuing any one or more of the kinds of buisinesses, purposes, objects or obligations above indicated, or owning or holding any property of any kind herein mentioned, or of any corporation owning or holding the stock or obligations of any such corporation.
- (e) To make and perform contracts of any kind and discription in carrying on its business, or for the purpose of attaining or furthering any of its objects. To borrow or raise money for any of the purposes of the corporation. To buy or sell notes, mortgages, or other evidences of debt, including notes and mortgages of this corporation. to own, buy and sell real and personal property. To mortgage, hypothecate or otherwise encumber any of said property. To endorse, guarantee and secure the payment and satisfaction of bonds, coupons, mortgages, debentures, obligations, and evidence of indebtedness, and to do any and all other acts and things, and to exersise any and all other powers which a co-partnership or natural person could do and exerise, and which now or hereafter be authorized by law. To have offices, conduct its business, and promote its objects within and without the State of Idaho, without restriction as to place or amount, and this corporation shall have the power to hold meetings within and without the State of Idaho, as may be determined from time to time by its By-Laws.
- (f) In general, but in connection with the foregoing, said corporation shall have and exersise all the powers conferred by the State of Idaho upon business corporations, it being expressly provided that the foregoing enumeration of special powers shall not be held to limit or restrict in any manner such general powers.

ARTICLE III DURATION

The period of existence and duration of life of this corporation shall be perpetual.

ARTICLE IV PLACE OF BUSINESS

ARTICLE V STOCK

This corporation is authorized to issue one class of capital stock which shall be designated as common stock. The total numbers of shares of common stock this corporation shall be authorized to issue is 5000 shares. The par value of the common stock shall be \$ 1.00 per share. The aggregate par value of this common stock shall be \$ 5000.00.

The entire voting power of the corporation shall be vested in the holders of common stock and every shareholder of record shall have the right, at every shareholder's meeting, to one vote for every share of common stock standing in his name on the books of the corporation.

The capital stock of this corporation shall be nonassessable, and the private property of the shareholder's of this corporation and shall not be liable for the debts, obligations and liabilities of the corporation.

ARTICLE VII

DIRECTORS

Directors are Ruby D Straight, Wallace E Straight and Tony Pruitt.

The number of directors of this corporation shall be at least three (3) and such additional number of directors not exceeding seven (7), as may be determined from time to time by the By-Laws of this corporation.

- (a) At all elections of directors of this corporation each stockholder of common stock shall be entitled to as many votes as shall equal the number of votes which he would be entitled to cast for the election of directors with respect to his shares of stock multiplied by the number of directors to be elected, and he may cast all votes for a single director, or may distribute them among the number to be voted for, or any two or more of them, as he may see fit.
- (b) More than one-half of the directors shall be necessary to constitute a quorum of the Board of Directors for the transaction of business at any meeting, but a lesser number may adjourn the meeting.

ARTICLE VIII

POWERS

The Board of Directors if this corporation shall have the power to repal and amend the By-Laws of the corporation and adopt new By-Laws. Such power shall not extend to making or altering any By-Laws fixing the qualifications, classifications, terms of office, or compensation of the Board of Dorectors, and this authority shall not be interpreted as taking from the shareholder's that power and authority given to them by Section 30-134 Idaho Code.
