

6                    Pursuant to the provisions of Section 30-1-61 of the  
7 Idaho Business Corporation Act, the undersigned corporation  
8 adopts the following Articles of Amendment to its Articles of  
9 Incorporation:

10                   1. The name of the corporation is S.I.R. INC.

11                   2. The following amendment of the Articles of  
12 Incorporation was adopted by the shareholders of the corporation  
13 on July 13, 1984 in the manner prescribed by the Idaho Business  
14 Corporation Act:

15                   Article 1 is amended changing the name of  
16 the corporation to TECHNICAL EQUITIES INTERMOUNTAIN,  
17 INC.

18                   3. The number of shares of the corporation outstanding  
19 at the time of the adoption was 5,000 and the number of shares  
20 entitled to vote thereon was 5,000.

23 held for the purpose of voting for or against the amendment.




