ARTICLES OF AMENDMENT

to the

ARTICLES OF INCORPORATION

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- The name of the corporation is S.I.R. INC.
- The following amendment of the Articles of 2. 12 Incorporation was adopted by the shareholders of the corporation 13 on July 13, 1984 in the manner prescribed by the Idaho Business Corporation Act:

Article 1 is amended changing the name of the corporation to TECHNICAL EQUITIES INTERMOUNTAIN, INC.

- 3. The number of shares of the corporation outstanding at the time of the adoption was 5,000 and the number of shares entitled to vote thereon was 5,000.
- These Articles of Amendment are executed by the only shareholder of the corporation and as such no meeting was held for the purpose of voting for or against the amendment.


