ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a corporation under the Idaho Nonprofit Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Eagle Valley Riders, Inc.

SECOND: The corporation is a nonprofit corporation organized under Idaho Code § 30-301 et seq.

THIRD: The period of the corporation's duration is perpetual.

FOURTH: The purpose for which the corporation is organized is as follows:
Nonprofit Horse Riding Club Organization

FIFTH: There shall be no capital stock in the corporation. There shall be one class of members in the corporation; the designation of the membership class, manner of qualifying for membership and rights of membership in the corporation shall be set forth in the Bylaws of the corporation.

SIXTH: Notwithstanding any other provision of these Articles of Incorporation; the corporation shall not carry on any activities not permitted to be carried on by a corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1954, as now in force or as may afterwards be amended. This corporation is organized exclusively for religious, charitable, scientific, literary, or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

SEVENTH: In no event shall any income or assets of this corporation be distributed to or inure to the benefit of any member, director, or officer of this corporation, either directly or

indirectly, other than as bona fide expenses in carrying out the directions and authorities of the Board of Directors and officers hereof in carrying out the purposes of the corporation. In the event of the termination, liquidation, or dissolution of this corporation for any reason, after paying or adequately providing for the debts of the corporation, all of the remaining assets thereof shall be distributed to such organizations as have established their tax exempt status under 501(c)(3) of the Internal Revenue Code as the Directors of the corporation shall determine by majority vote.

EIGHTH: The territory in which the corporation's activities are principally to be conducted is the State of Idaho.

NINTH: The corporation shall not, in its membership or otherwise, discriminate against any person on the basis of race, color, religion, sex, or national origin.

TENTH: The name of the initial registered agent and street address of the initial registered agent of the corporation is:

ELEVENTH: The number of directors of the corporation shall be as provided in the Bylaws of the corporation, but in no event shall the number of directors be less than three (3). TWELFTH: The Board of Directors shall manage the affairs of the corporation.

THIRTEENTH: The members of the corporation shall not be personally liable for the debts, liabilities, or obligations of the corporation to any extent whatsoever.
