ARTICLES OF INCORPORATION

OF

THESE ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION OF P & S, INC. are herein executed by said corporation pursuant to the provisions of I.C. §30-1-61, as follows:

Ι.

The name of the corporation was originally P & S, INC., but by these Articles of Amendment is rechanged to J LAZY S, INC.

II.

The date of the adoption of this Amendment by the share-holders of said corporation is June 1, 1986, and pursuant to the requirements of I.C. §30-1-61(d), one hundred percent (100%) of the outstanding shares voted in favor of this amendment, and no shares voted against. There are no shares which the corporation is authorized to issue which do not have voting rights.

III.

The Amendment to the Articles of Incorporation of said corporation is as follows: To change the name of said corporation from "P & S, INC." to "J LAZY S, INC."

IV.

These Articles of Amendment do not provide for an exchange, reclassification or cancellation of any issued shares, nor do they affect the amount of stated capital of the corporation.
