ARTICLES OF INCORPORATION OF

(A NONPROFIT CORPORATION)

THE UNDERSIGNED, acting as incorporator of a nonprofit corporation under the Idaho, refit Corporation Act. Idaho Code, 830-3-1, et. seg., adopts the following Articles of the control of the code Non-Profit Corporation Act, Idaho Code §30-3-1, et. seq., adopts the following Articles 6 Incorporation.

# ARTICLE I

The name of the Corporation is Kootenai Neighbors Group Association, Inc. The Corporation is a nonprofit Corporation.

## ARTICLE II

The period of the Corporation's duration is perpetual.

# ARTICLE III

The purpose for which the Corporation is organized is to manage, oversee, and direct the use, operation, maintenance, and perpetuation of a community dock system, in accordance with such permit as the Idaho Department of Lands may hereafter issue, on property owned by the Corporation. Said use and management shall be overseen by the Corporation for the benefit of the "Membership" in the Corporation, as "Membership" is defined herein. The rights and liabilities of the Corporation's Membership in and to the Corporation's community dock and littoral rights, all as defined herein, or as hereafter amended, shall be subject to the terms of such "Covenants, Conditions, and Restrictions" as the Corporation may hereafter record as against the parcels of real property located in Kootenai County that are identified as Members herein in accordance with Article VII and any amendments thereto. The Corporation may also transact any and all other lawful business for which corporations may be incorporated under the Idaho Non-Profit Corporation Act. The Corporation shall, subject to the terms of said "Covenants, Conditions, and Restrictions," and the terms of these Articles and the Corporation's Bylaws, and any amendments thereto, manage, oversee, and enforce such rules and regulations as may be enforced, in accordance with the terms of said instruments, as to the Member's rights and liabilities with respect to the community dock and littoral rights. The affairs of the Corporation shall be managed by its Board of Directors.

In the event the Corporation is dissolved in conformity with both Idaho law (the Idaho Non-Profit Corporation Act, I.C. §30-3-1, et seq., as it now exists or is hereafter amended) and the provisions of any "Covenants, Conditions and Restrictions" pertaining to the real properties described in Article VII, then any assets of the Corporation which remain after paying all corporate obligations and liabilities shall be liquidated and distributed to the Corporation's Members (to be determined as of such date as the Corporation's Board fixes in its discretion) pro ratably.

## **ARTICLE VII**

Membership in the Association is as defined herein. There are three (3) parcels of real property located in Kootenai County, Idaho which are identified below. Each parcel qualifies the Owner(s) of the same for membership in the Corporation. There shall be no membership in the Corporation separate and apart from membership arising by ownership of one of the three (3) identified parcels below. A sale or transfer of the property shall constitute a transfer of the membership appurtenant thereto to the successor owner or holder thereof. The Owner(s) of a parcel giving rise to membership rights herein shall be entitled to exercise one (1) vote on all matters of corporate governance. All Members shall enjoy the right of cumulative voting in any election for Directors of the Corporation.
