KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, President and Secretary, respectively, of TIMES-NEWS-ACE PRINTING, INC., do hereby certify as follows:

That TIMES-NEWS-ACE PRINTING, INC., is a corporation duly organized and existing under and by virtue of the laws of the State of Idaho;

That a special meeting of the Board of Directors of TIMES-NEWS-ACE PRINTING, INC., was duly held on the 29th day of January, 1973, at ~~ten o'clock A.M.~~ in the City of Twin Falls, State of Idaho, at which meeting all of the members of the Board of Directors of said corporation were present; that at said meeting a resolution was regularly proposed, voted upon and adopted by the unanimous vote of all of said directors, amending the Articles of Incorporation of said corporation; that the following is a full, true and correct copy of the resolution of said Board of Directors amending the Articles of Incorporation:

"BE IT RESOLVED That Article VI of the Articles of Incorporation of Times-News-Ace Printing, Inc., be amended by amending Article VI so that it shall read as follows:

'ARTICLE VI.

There shall be one class of capital stock of the corporation and it shall be known as common stock. The amount of the authorized common stock of said corporation shall be \$220,000.00 divided into 2,200 shares of common stock at the par value of \$100.00 per share, said stock to be non-assessable."

That said resolution of the Board of Directors was approved, on the 29th day of January, 1973, by the written consent of Hammond Publishers, Inc., and Lincoln McGinnis, the holders of all the shares of said corporation entitled to vote at the time said

consent was given; that the following is a full, true and correct copy of said consent of said shareholders to the amendment to the Articles of Incorporation:

"We, the undersigned, holding all of the shares of stock of Times-News-Ace Printing, Inc. entitled to vote, hereby, and by these presents do, consent to, confirm and ratify, the amendment of the Articles of Incorporation made by the Board of Directors of Times-News-Ace Printing, Inc., at a special meeting held on the 29th day of January, 1973, at ten o'clock A.M., which amendment is as follows, to-wit:

"BE IT RESOLVED That Article VI of the Articles of Incorporation of Time-News-Ace Printing, Inc., be amended by amending Article VI so that it shall read as follows:

'ARTICLE VI.

There shall be one class of capital stock of the corporation and it shall be known as common stock. The amount of the authorized common stock of said corporation shall be ~~\$220,000.00~~ divided into 2,200 shares of common stock at the par value of \$100.00 per share, said stock to be non-assessable.'

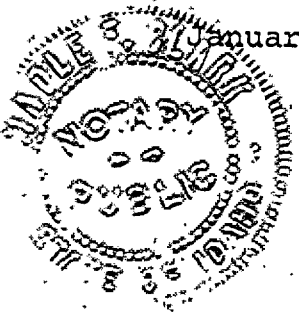
