
CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION

DEWAYNE L. MCKINLEY, INC.

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned
being two (2) natural persons of adult age, both of whom are
citizens of the United States, or of its territories or
possessions, have this day voluntarily associated ourselves for
the purpose of forming a private corporation under the laws of
the State of Idaho, and to that end hereby adopt Articles of
Incorporation as follows:

ARTICLE 1

The name of this Corporation shall be DEWAYNE L. MCKINLEY,
INC.

ARTICLE II

The duration of the corporation shall be perpetual.

ARTICLE III

The purpose for formation of the Corporation is to operate and maintain heavy motorized or mobile equipment for hauling of logs and other forest products or general cargo. To contract or sub-contract with land owners or logging companies to haul forest products, and any other lawful purposes for which corporations may be incorporated under the Idaho General Business Corporation Act.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is 100,000. All such shares shall be of

one class, known as common stock. All of such shares shall be without par value.

ARTICLE V

There shall be no transfer of shares of stock in the said corporation without the unanimous consent of the directors of said corporation.

ARTICLE VI

The initial registered office of said corporation is located at 1142 Hwy. 11, Weippe, Idaho 83553, and the initial registered agent of said corporation is DeWayne L. McKinley of 1142 Hwy. 11, Weippe, Idaho 83553.

ARTICLE VII

The initial Board of Directors consists of two persons, namely: DeWayne L. McKinley of 1142 Hwy. 11, Weippe, Idaho 83553 and Kathryn L. McKinley of 1142 Hwy. 11, Weippe, Idaho. The initial directors shall serve as directors until the first annual meeting of shareholders or until their successors be elected and qualify.

ARTICLE VIII

The incorporators of the said corporation are: DeWayne L. McKinley and Kathryn L. McKinley of 1142 Hwy. 11, Weippe, Idaho 83553.

ARTICLE IX

The personal liability of a director to the corporation or its shareholders for monetary damages for breach of fiduciary duties as a director is herewith eliminated, however this

provision shall not eliminate or limit the liability of a director:

- a. For any breach of the director's duty of loyalty to the corporation or its stockholders.
- b. For acts or omissions not in good faith or which involve intentional misconduct or knowing violation of law.
- c. Any act or omission provided for under Section 30-1-48, Idaho Code.
- d. For any transaction from which the director derived an improper personal benefit.
