AMENDMENT TO ARTICLES OF INCORPORATION

of

ELKHORN PROPERTY OWNERS' ASSOCIATION, INC.

BE IT KNOWN, that we, the undersigned President and Secretary-Treasurer, respectively, of Elkhorn Property Owners' Association, Inc., do hereby certify in accordance with the provisions of Section 30-146, Idaho Code, as follows:

1. On November 7, 1972, at a Special Meeting duly called by the Board of Directors, at which members entitled to vote in excess of two-thirds of the corporation's total votes were represented in person or by proxy, the following Resolution was unanimously adopted amending the Articles of Incorp cration, as follows:

"BE IT RESOLVED that Article VII of the Articles of Incorporation be amended to include a Section G to read as follows:

'G. The mortgaging, encumbering, or other disposition of any property, real or personal, of the corporation valued in excess of One Thousand Dollars (\$1,000.00) shall require the prior consent of at least fifty-one (51%) percent of the voting power of each class of the membership of the corporation.'

and that the president and secretary-treasurer, be, and they hereby are, authorized and directed to prepare a duly certified certificate of this Amendment of the Articles of Incorporation, and to file the same with the Secretary of the State of Idaho, and to such other place or places as may be necessary and/or convenient."

2. We do further certify that the undersigned are authorized, empowered and directed by the Resolution adopted by the Special Meeting of the members of the corporation as set forth in paragraph 1 immediately above to cause this Amendment to the Articles of Incorporation to be prepared, executed and filed as provided by the laws of Idaho.
