

Certificate of Incorporation of the
Deep Creek Newlew Valley Irrigation
Company a Corporation formed for
the purposes hereinafter expressed

Article 1. The Corporate name of this
Corporation shall be the
Deep Creek Newlew Valley
Irrigation Company

Article 2. The principal place of
business of said Corporation
is intended to be within the County of
Quincy in the Territory of Idaho ~~of~~
and the County of Bot Elder in the
Territory of Utah and the principal place
of business and office of said Corporation
shall be at Deep Creek in the County
of Quincy and Territory of Idaho.

Article 3. The object for which this
Corporation is formed is to
carry water from Deep Creek Newlew Valley
in the County of Quincy and Territory of
Idaho to Bot Elder County in the
Territory of Utah to construct and maintain
the necessary ditches therefor and
dispose of such water in said Counties
of Quincy and Bot Elder for irrigation
and other purposes, to purchase own
and hold the necessary land and right
of way in such ditches and the carrying
on of said business and generally all

1 business Connected with or appertaining
2 to the Company ^{and} disposition of water
3 as aforesaid.

4 Article 4. The amount of the
5 Capital stock of this
6 Corporation is and shall be the
7 sum of Five Thousand Dollars
8 and the sum shall be divided into Two
9 Hundred and Fifty shares of Twenty Dollars
10 Each

11 Article 5. This Corporation shall continue
12 and exist for the period
13 of Twenty Five years from ^{and} after
14 its organization

15 Article 6. There shall be five Trustees
16 of this Corporation
17 who shall manage the business
18 of said Corporation for the first
19 three months after the formation
20 thereof. The names ^{and} residences
21 of said first five trustees are as
22 follows, Joseph Robbins of said
23 County of Auda, John Eymon
24 of said County of Bot Elder, Thomas
25 Phillipps of said County of Auda
26 and Peter B Johnson of said County of

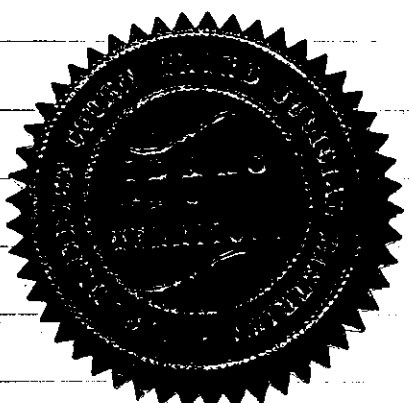
